Contest Specifications:

- 1. The competitor will search the suspect, handcuff the suspect, secure evidence or weapons and complete an incident report. Scenarios include a suspicious person and felony arrest.
- 2. The competitor will perform first aid on a patient functioning as law enforcement. Possible scenario: CPR, airway management and rescue breathing according to the AHA guidelines.
- 3. The competitor will fill out a fingerprint card, fingerprint a suspect and identify the type of fingerprints.
- 4. The competitor will utilize the PA crime codes and vehicle code books.

Accident

Call for service: Basic two-vehicle accident at an intersection.

First vehicle stopped suddenly at a stop sign and second vehicle rear ended the first vehicle.

First driver will state they stopped for the stop sign, and was hit by the second vehicle.

Second driver will state the first driver slammed on his brakes suddenly, so there was no way he could stop before hitting the first vehicle.
